## **Recognizing Types of Academic Misconduct**

There are several different categories that different acts of academic misconduct can fall into. Click <u>HERE</u> to see the different categories and examples of acts that constitute a violation of the Aggie Honor Code.

## **Gathering Evidence of the Violation**

Due process requires that an allegation of academic misconduct be based on evidence and facts, not opinions. Click <u>HERE</u> for guidance on the evidence that you need to have at hand when initiating the process.

#### Deciding Whether to Handle Autonomously or Refer to Honor Council

There are a number of factors that go into an instructor's decision of whether to handle a violation autonomously by meeting with the student, assigning the sanction, and simply putting a violation on file with AHSO or to refer to entire matter to the Honor Council. ## **Determining an Appropriate Sanction**

### Student Appeal of an Autonomously Handled Case

It is possible that a student may disagree with your assessment of the situation and appeal either the violation or the sanction. The rules on appeals are very specific. Click <u>HERE</u> to see the four legitimate bases for appeal and the process for the appeal to be accepted or rejected.

## <u>Understanding the Investigation Process</u>

If the case has gone to the honor council, either through a referral or an autonomous appeal, the office will conduct a fact finding investigation prior to the Hearing process. Click <u>HERE</u> to learn what to expect during an investigation.

## What to Expect in a Hearing

An Honor Council Hearing is an academic process where evidence is put forth before a panel of faculty and student Honor Council members to allow them to make a decision on whether there was sufficient proof of an academic misconduct violation having occurred and if so, to assign an appropriate sanction. Because of the implications, a hearing can be an uncomfortable event for the student and the instructor. Click <u>HERE</u> to learn what to expect during a hearing.
